GMB SLAMS'WE'RE LISTENING'CLAIM AS COLLEAGUE CIRCLE SAYS:

IF YOU ARE COLD AT WORK JUST WORK HARDER

GMB negotiators were stunned to hear that a recent Colleague Circle reaction to a request for more personal protective clothing to protect cold employees was that they should work harder.

This attitude clearly shows that GMB members' demand for independent Health & Safety Committees is necessary. Only when Health and Safety issues are treated seriously will GMB members begin to believe the company's 'We're Listening' claim.

GMB members working in cold areas at Asda tell GMB that the company is failing in its legal duty to supply free Personal Protective Clothing (PPC) and warm wear and that they are cold. This must change.



Whatever your job at Asda there is a legal requirement on Asda to deal with any risks and hazards that you may be exposed to. One of the most important factors for Asda workers is PPC.

Identifying this need is simple. Any Asda employee working in a cold environment, whether refrigeration, doors open to the outside or filling freezers, are likely to get cold. If the risk assessment identifies that your job requires PPC or warm wear then there is an absolute obligation for Asda to provide it free of charge. It is ASDA's responsibility to pay for it as you are working on their premises.

Providing PPC is a non-confrontational issue in virtually every other workplace in the UK. Why can't ASDA be the same?

that Colleague Circles are provided with a breakdown of Asda's budget to cover all heath & safety matters including the free issue of Personal Protective Clothing.

As Asda's operating profit for year ending 31st December 2007 was £643.5 million, it can well afford to increase its spending on PPC and more for its hard working staff.
